1. We are a pedal bike rental company offering social and physical entertainment to our passengers thru pub crawls, company outings, family reunions, city tours and bachelor and bachelorette parties. As such, per State of Michigan Laws, there is **NO ALCOHOL ALLOWED ON THE GREAT LAKES PUB CRUISER.**
2. You may bring snacks to consume and non alcoholic beverages in plastic bottles. No glassware please.

3. We are a “Truly Green Pub” and very ecologically conscious so if you bring any snacks or non-alcoholic beverages make sure to properly dispose of them in our recycle trash cans.
4. Please do not litter our beautiful city in any way.
5. The tour chauffer is responsible for the Great Lakes Pub Cruiser and his/her decisions are final.
6. Inappropriate behavior before, during or after a tour will result in the offending passenger/s immediately disembarking the Great Lakes Pub Cruiser.  
These include but are not limited to:
  - arriving/becoming excessively intoxicated
  - public urination
  - inappropriate language(swearing)
  - littering
  - loitering more than 15 minutes at the end of a tour
  - excessive noise
7. Severe transgressions of the above will result in the chauffer ending the tour immediately, and causing a Late/Damage fee of \$200 to be charged to the renters’ credit card.
8. All rules regarding the consumption of alcohol in the State of Michigan will apply to all passengers before, during and after a Great Lakes Pub Cruiser tour.
9. Any person arriving in an intoxicated state shall not be allowed to board and ride the Great Lakes Pub Cruiser.
